ORDER:

The Hon'ble Minister (Municipal Administration, Rural Development, Law, Courts and Prisons) on 30.04.2013 has made the following announcement on the floor of Legislative Assembly, while replying to Demand No.24 Prisons: -

“மத்திய சிறைகளில் ரூ.221.30 இலட்சம் தொடரா செலவினத்தில் பாதுகாப்பினைப் பலப்படுத்தும் வகையில், 60 மேம்படுத்தப்பட்ட சிசிடிவி கேமராக்கள் சிறைகளில் முக்கியமான இடங்களில் பொருத்தப்படும்”

2. In pursuance to the above announcement, the Additional Director General of Police / Inspector General of Prisons has sent a detailed proposal wherein, he has stated that at present, 3 CCTV cameras, with recording facility, were provided to 7 Central Prisons and 2 Special Prisons for Women, Vellore and Trichy at a cost of Rs.54.17 lakhs during the year 2007-08. 10 Nos. of CCTV cameras were purchased and installed in the Central Prison-2, Puzhal, during the year 2009-10, at a total cost of Rs.17.11 lakhs. The present CCTV coverage is found to be highly inadequate to ensure complete coverage of all sensitive locations within the vast Campus in Prisons. He has further stated that provision of additional CCTV system with recording facility at vulnerable points in all Central Prisons, Special Prisons for Women and District Jail and Borstal School, Pudukottai is very essential to monitor the movement of prisoners and staff inside the prisons and, thereby, prevent any untoward incident inside the Prisons. In order to monitor the prisoners as well as the visitors, it is proposed to provide additional 60 Nos. of CCTV cameras to 9 Central Prisons, 3 Special Prisons for Women and District Jail & Borstal School, Pudukottai. These additional 60 cameras will be fixed at Main Gates, Admission Gates, Interview rooms (one at prisoner side and one at visitor side), High Security Blocks and in places like Hospitals, Towers

etc., where it is necessary to monitor the movements of the prisoners and staff.

3. The Additional Director General of Police / Inspector General of Prisons has also stated that the additional 60 CCTV cameras, with recording facility will be provided to all Central Prisons, Special Prisons for Women and District Jail & Borstal School, Pudukottai, as listed below: -

The Additional Director General of Police / Inspector General of Prisons has, therefore, requested the Government to issue necessary administrative sanction for the purchase and installation of 60 CCTV system to 9 Central Prisons 3 Special Prisons for Women and District Jail & Borstal School, Pudukottai, at a total cost of Rs.221.30 lakhs, for effective surveillance of prisoners as well as staff and visitors, so as to prevent any untoward incident in the prisons.

5. The Government have carefully examined the proposal of the Additional Director General of Police / Inspector General of Prisons, Chennai and have decided to accept it. Accordingly, the Government accord administrative sanction for a sum of Rs.221.30 lakhs (Rupees two crores twenty one lakhs and thirty thousand only) towards the purchase and installation of 60 CCTV system to 9 Central Prisons 3 Special Prisons for Women and District Jail & Borstal School, Pudukottai for effective surveillance of prisoners as well as staff and visitors, so as to prevent any untoward incident, as detailed in the Annexure appended to this order.

6. The expenditure sanctioned in paragraph 5 above shall be debited to the following head of account: -

"2056-00-Jails-101. Jails - I. Non - Plan - AA. Jails
(Other than Sub-Jails) 19 Machinery and Equipments
- 01 Purchase (DPC: 2056-00-101-AA -1916)".

7. The expenditure sanctioned in paragraph 5 above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will be initially met by an advance from the Contingency Fund. Orders for sanction of advance from the Contingency fund will be issued by the Finance (BG-I) Department. The Additional Director General of Police / Inspector General of Prisons is requested to apply for Contingency Fund Advance in the prescribed form along with the copy of this order to Finance (BG-I) Department, for sanctioning the advance. He is also requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2013-14 to Finance Department at the appropriate time without fail.

8. This order issues with the concurrence of the Finance Department vide its U.O.No.54081/Home-II/2013-1, dated 04.10.2013 and with Additional Sanction Ledger No.1475 (One thousand four hundred and seventy five).
